Subject: New York City Local Law 196 and OSHA 30 Requirement

Pursuant with New York City Local Law 196 effective **June 1, 2019** all **Local Union No. 3 members in the Construction Division** will be required to have a **valid OSHA 30 Hour Construction Safety card completed within the past five years**. Courses completed after October 16, 2017 must have been completed online or in a live classroom setting. If the training is done online it must be taken using our voice authentication system to ensure that the individual receiving the training is present for the entirety of the course. All OSHA cards obtained outside of the EESISP system are subject to the approval of the Safety Department.

The Electrical Employers Self Insurance Safety Plan has made arrangements for your employees to complete this requirement with an online version of the OSHA 30-Hour Course for Construction at no separate charge to your company or the Local #3 member. In order to gain access to this training, members must make arrangements to be voice-printed and photographed for a Department of Buildings Site Safety Training (SST) ID card at the Joint Industry Board by calling 718-820-4155.

We urge you to inform all of your employees that may be effected by the new law of these requirements and instruct them to make arrangements to be voice printed, have their photo taken and start working towards completing the OSHA 30 Hour Course as soon as possible. **The goal should be to complete this process by April 1, 2019 to avoid administrative delays as we approach the deadline date for compliance.**
