### **RE: Paid Family Leave Deduction Increase**

The Paid Family Leave Deduction will increase to **\$7.00 per week** for all 'A' rated Journeypersons and for all ADM employees receiving the 'A' rate of pay and above effective week 1 of 2022, week ending Wednesday, January 5<sup>th</sup>, 2022.

The Paid Family Leave Deduction for NYC and White Plains Apprentices, 'M' Helpers, Residential Wiremen and Tele-Data Helpers will remain at **\$3.08 per week**.

The Paid Family Leave Deduction for all other classifications will increase **to \$4.00 per week** effective week 1 of 2022, week ending Wednesday, January 5<sup>th</sup>, 2022.

The contribution to EESISIP for workers compensation and disability is also increased week 1 of 2022, week ending January 5<sup>th</sup>, 2022. Please see attachment for the new rates. Rate adjustments based on preferred or surcharge status may be applicable as determined by the EESISIP Trustees
