**REPORT OF SUMMARY PLAN INFORMATION**

**2021 Plan Year (October 1, 2021 – September 30, 2022)**

In accordance with ERISA §104(d), the Trustees of the Pension, Hospitalization and Benefit Plan of the Electrical Industry – Pension Trust Fund are providing the following Report of Summary Plan Information to unions that represent Plan participants and employers obligated to contribute to the Plan.

Except as otherwise specified, all information in this Report pertains to the October 1, 2021 – September 30, 2022 Plan Year.

**1. Contribution Schedule and Benefit Formula Information.**

The Employers maximum contribution percentage of wages to the Pension Fund and the companion Health Fund is 49.28%. The maximum contribution percentage contributed to the Pension Fund is 13.39%.

Pension Credits are valued at up to \$100 per credited year of service for all future years of service starting in 2022. Prior years of service remain unchanged.

**2. Number of Contributing Employers.**

For the plan year ending September 30, 2022, 474 employers were obligated to contribute to the Plan.

**3. Employers Contributing More Than 5%.**

During the plan year ending September 30, 2022, the employer listed below contributed more than 5% of total contributions to the Plan:
