IMPORTANT NOTICE:

TO ALL ACTIVE AND RETIRED ELIGIBLE PARTICIPANTS OF THE DENTAL BENEFIT PLAN OF THE ELEVATOR DIVISION

Dear Participant:

The Trustees of the Dental Benefit Plan of the Elevator Industry (“the Plan”) have adopted the changes listed below to the Plan to be effective March 1, 2011. This Notice supplements and replaces corresponding material in your Summary Plan Description and is intended to constitute a summary of material modifications of the Plan.

Please read this Notice carefully to determine how these changes apply to you and/or your eligible dependents.

Changes to the Dental Benefit Plan of the Elevator Industry Effective March 1, 2011:

1. The prosthetic annual maximum is raised from \$3,000 to \$4,000. **This applies to all services rendered on or after March 1, 2011.**
2. Non-cosmetic dental implants will be covered for charges up to \$750. Associated charges for abutments and bone grafts will also be covered. *This benefit is part of the \$4,000 annual prosthetic maximum and is part of the fee-for-service program only. Participants in the DDS preferred provider organization and the Empire Dental Managed Network Program are subject to the fee-for-service plan allowances for this benefit only.* **This applies to all services rendered on or after March 1, 2011.**
