## REPORT OF SUMMARY PLAN INFORMATION

### 2018 Plan Year

In accordance with ERISA §104(d), the Trustees of the Employees Security Fund of the Electrical Products Industries Pension Plan are providing the following Report of Summary Plan Information to unions that represent Plan participants and employers obligated to contribute to the Plan.

Except as otherwise specified, all information in this Report pertains to the 2018 Plan Year.

1. Contributions are remitted by Employers based on a collectively bargained rate that is applied to employees' weekly wages. Approximately 20% of these contributions are allocated to the Pension Plan.

Pension Credits are currently valued at \$22.50 per credited year of service.

## 2. Number of Contributing Employers.

For the plan year ending December 31, 2018, 75 employers were obligated to contribute to the Plan.
