REPORT OF SUMMARY PLAN INFORMATION

2019 Plan Year (October 1, 2019 – September 30, 2020)

In accordance with ERISA §104(d), the Trustees of the Pension, Hospitalization and Benefit Plan of the Electrical Industry – Pension Trust Fund are providing the following Report of Summary Plan Information to unions that represent Plan participants and employers obligated to contribute to the Plan.

Except as otherwise specified, all information in this Report pertains to the October 1, 2019 – September 30, 2020 Plan Year.

1. Contribution Schedule and Benefit Formula Information.

Effective April 9, 2020, the Employers maximum contribution percentage of wages to the Pension Fund and the companion Health Fund equivalent of 47.825% was increased to 48.502%. The percentage contributed to the Pension Fund was 13.39%.

Pension Credits are valued at up to \$85 per credited year of service.

2. Number of Contributing Employers.

For the plan year ending September 30, 2020, 483 employers were obligated to contribute to the Plan.

3. Employers Contributing More than 5%.

During the plan year ending September 30, 2020, the employers listed below contributed more than 5% of total contributions to the Plan:
