**RE: Paid Family Leave Deduction Decrease**

Dear Employer:

The Paid Family Leave Deduction will decrease, this change will take effect starting week 6, 2024, week ending date February 7<sup>th</sup>, 2024.

The Paid Family Leave Deduction will decrease to \$6.00 per week for all 'A' rated Journeypersons and for all ADM employees receiving the 'A' rate of pay and above.

The Paid Family Leave Deduction for NYC and White Plains Apprentices, 'M' Helpers, Residential Wiremen and Tele-Data Helpers will decrease to \$2.60 per week.

The Paid Family Leave Deduction for all other classifications will decrease to \$3.40 per week effective week 6 of 2024, week ending February 7<sup>th</sup>, 2024.
